Notice is given that Eastleigh Borough Council adopted the Eastleigh Borough Local Plan 2016-2036 on **25th April 2022** in accordance with the above regulations.

The Local Plan sets the planning strategy for the borough for a 20 year period up to 2036. It replaces the Adopted Eastleigh Borough Local Plan 2001-2011.

The Local Plan has been subject to an independent examination conducted by the Planning Inspector Christa Masters MA (Hons) MRTPI. Examination hearing sessions were held between November 2019 – January 2020 and a further additional hearing session held in January 2021. The Inspector's report was published on 14th March 2022 and is available at www.eastleigh.gov.uk/lpexamination. This report concluded that the Local Plan is sound and legally compliant, subject to incorporating the final Main Modifications recommended by the Inspector and set out in the Appendix to the report. These modifications are incorporated in the adopted Local Plan.

Any person aggrieved by the adoption of the Eastleigh Borough Local Plan may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act 2004. Any challenge pursuant to Section 113 must be made on the grounds that the document is not within the appropriate power and/or a procedural requirement has not been complied with. Any such application should be made no later than **6th June 2022** (six weeks from the date of adoption).
