

**THE BOROUGH OF EASTLEIGH (BURSLEDON, HAMBLE-LE-RICE AND
HOUND) (AMENDMENT NO 13) ORDER 2022**

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. In this Order the Principal Order means The Borough of Eastleigh (Bursledon, Hamble-Le-Rice and Hound) (Consolidation) Order 2012 as amended.;
2. The following shall be added to Article 20 of the Principal Order:
 - (i) between the hours of 8.00am and 8.00pm Monday - Sunday in the roads specified in the third Schedule to this Order
3. This Order shall come into operation on 26 January 2023 and may be cited as the "The Borough of Eastleigh (Bursledon, Hamble-Le-Rice and Hound) (Amendment No 13) Order 2022."

Prohibition and Restriction of Waiting

4. The contents of Schedule 1 shall be inserted into the Fourth Schedule to the Principal Order.
5. The contents of Schedule 2 shall be deleted from the Fourth Schedule to the Principal Order
6. The contents of Schedule 3 shall be inserted as a new Twenty-Ninth Schedule to the Principal Order.
7. The contents of Schedule 4 shall be inserted as a new Twenty-Seventh Schedule to the Principal Order replacing previous Twenty-Seventh Schedule inserted by item 11c in The Borough of Eastleigh (Bursledon, Hamble -Le-Rice and Hound) (Amendment No 8) Order 2019.
8. The contents of schedule 5 shall be inserted as a new Twenty-Eighth Schedule to the Principal Order.

	Beaulieu Road	South-east	From its junction with Sydney Avenue south-westwards for a distance of 15.5 metres
	Coach Road	South-east	From its junction with Norbury Gardens north-eastwards for a distance of 35 metres
	Coach Road	North-west	From its junction with the crescent shaped spur of Coach Road in a south-westerly direction for 6 metres
	Coach Road (Crescent shaped spur)	Both	From its junction with Coach Road (main) in a north-westerly direction for 10 metres
	Deanfield Close	North-west	From its junction with Hamble Lane for a distance of 55 metres
	Deanfield Close	South-east	From its junction with Hamble Lane for a distance of 51 metres
	Flowers Close	South-east	From its junction with Sydney Avenue south-westwards to the northernmost boundary of No 1 Flowers Close
	Flowers Close	North-west	From its junction with Sydney Avenue south-westwards for a distance of 10 metres
	Friarscroft	Both	From its junction with Westwood Road to a point 13.5 metres north-eastwards
	Lowford Hill	South, West and North	South side, from a point 33 metres east of the western kerb at the western end of the cul de sac westwards, then northwards and then eastwards to a point opposite the common boundary of "Pine Wood" and "Cedars" a total distance of 70 metres
	Oakwood Way	Both	From its junction with Satchell Lane eastwards for a distance of 12 metres
	Satchell Lane	East	From a point 19.5 metres north of its junction with Oakwood Way to a point 10 metres south of that junction
	Sydney Avenue	North-east	From a point 10 metres north-west of its junction with Sydney Avenue (crescent shaped spur) to a point 10 metres south-east of that junction
	Sydney Avenue	South-west	From a point 10 metres north-westwards of its junction with Flowers Close to a point 10 metres south-eastwards of that junction

	Sydney Avenue (Crescent shaped spur)	Both sides	From its junction with Sydney Avenue (main) north-eastwards for a distance of 12 metres
	Westwood Road	North-east	From its junction with Friarscroft 10 metres in a north-west direction and 10 metres in a south-east direction

	Road	Side	Description
	Coach Road	South east	From its junction with Norbury Gardens north eastwards for a distance of 10m metres.
3.	Beaulieu Road	East	From its junction with Sydney Avenue in a southerly direction for a distance of 10 metres
	Deanfield Close	South East	From its junction with Hamble Lane for a distance of 41 metres

Schedule 3 No Waiting 8am – 8pm Mon - Sun (Addition) new Twenty-Ninth Schedule

	Road	Side	Description
	Sedgemoad	Both	The whole road from a point on each side 25 metres from the junction with Victoria Road

Schedule 4 Waiting limited to 1 hour, return prohibited within 2 hours Mon - Sat 8am - 6pm (replacement of Twenty-Seventh Schedule to the Principal Order)

	Road	Side	Description
1.	Coach Road Layby	South-east	From a point 16.5 metres south-west of its junction with Hamble Lane to a point 15 metres north-east of its junction with Grantham Avenue

Schedule 5 Waiting limited to 1 hour, return prohibited within 2 hours Mon - Sat 8am - 8pm (Addition) new Twenty-Eighth Schedule

	Road	Side	Description
	Grantham Avenue	South-west	6 metre length bay fronting No. 14 Grantham Avenue
