### Why do we need your personal information?

Who we may share your data with includes but is not limited to:	<ul style="list-style-type: none"> <li>Parish Council (where the voluntary role is in partnership with a Parish Council).</li> <li>Internal Audit.</li> <li>Next of Kin.</li> <li>EBC Officers.</li> </ul>
Lawful basis for using your personal data:	Article 6 (1) (a) – consent
Lawful basis for using your special personal data	Article 9 (2) (a) – explicit consent

### Who we might share your information with?

Your personal information will be treated as confidential, but it may be shared with other Council services in order to provide services, meet our legal obligations as a Local Authority, ensure our records are accurate and up-to-date and improve the standard of the services we deliver. It may also be shared with external organisations involved in delivering services on our behalf where the Council has a lawful basis to do so. We will only use your information in ways which are permitted by the General Data Protection Regulation and the UK Data Protection law.

- The Council has a duty to protect the public funds it administers and may use the information you have provided or share it with other bodies for the purpose of

preventing and detecting fraud. This includes participation in the Cabinet Office [National Fraud Initiative](#).

- We will NOT use your personal data for marketing products or services.

In the course of conducting our business, we may from time to time conduct voluntary surveys to collect information about how our services are performing, what improvements we could make and other information about the demographics and make-up of the borough. Only statistical information is ever shared, used, or analysed from these surveys.

We retain your personal information for as long as necessary to fulfil the purposes we collected it for, including for the purpose of satisfying any legal, accounting or reporting requirements, or to fulfil statutory obligations.
