#### THE BOROUGH OF EASTLEIGH (ARNOLD ROAD AREA) (RESIDENTS PARKING PLACES AND PROHIBITION AND RESTRICTION OF WAITING) (DISABLED PERSONS PARKING PLACES) (FOURTH ZONE) (CONTROLLED ZONE) (AMENDMENT NO. 11) ORDER 2017

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2, 4, 32 and 35 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

## PART 1- GENERAL

## Commencement and Citation

- This Order shall come into operation on 1<sup>st</sup> June 2017 and may be cited as the "Borough of Eastleigh (Arnold Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Fourth Zone) (Controlled Zone) (Amendment No. 11) Order 2017 <u>PART II – REVOCATIONS</u>
- 2. Each of the orders specified in column 1 of the First Schedule to this order is hereby revoked to the extent specified in column 2 of that schedule.

### PART III – PROHIBITION AND RESTRICTION OF WAITING

- In this Order the Principal Order means The Borough of Eastleigh (Arnold Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Fourth Zone) (Controlled Zone) Order 2004.
- 4. The Principal Order (as amended) is hereby amended as follows:




