NOTICE IS HEREBY GIVEN that the Eastleigh Borough Council pursuant to arrangements under Section 19 of the Local Government Act 2000 with Hampshire County Council has made the above mentioned Traffic Regulation Amendment Order in exercise of the powers of the said County Council under Sections 1, 2, 4, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police.

The general effect of this Order is to insert into The Borough of Eastleigh (Hedge End, West End and Botley) Consolidation Order 2015 new waiting restrictions, and amend some existing restrictions as detailed below:

a) 'No Waiting at Any Time' restrictions in the following roads:

b) 'No Waiting Monday to Friday 8am-9am and 2.30pm-3.30pm' restrictions in the following roads:

c) Amendment to Waiting Limited to 30 Minutes in One Hour, Monday to Saturday 9.00am – 6.00pm, by extending the 'No Waiting At Any Time' in Lower Northam Road Service Road on the north side between Wildern Lane and Cedar Close and relocation of disabled persons parking place on the south side service road.

Other Locations included within the Order to rectify an administrative error during the making of the Consolidation Order 2015:

Church Lane – existing restrictions at the junction with Granada Road and St Johns Road Clover Way – Existing restrictions at the junction with Turnpike Way Granada Road – Existing restrictions at the junction with Church Lane Herald Road – Existing restrictions along Herald Road Kennilworth Gardens – removal of no waiting at any time adjacent to the layby Pretoria Road – Existing restrictions at the junction with St Johns Road. St Johns Road – Existing restrictions at the junction with Pretoria Road. Seaton Close – Existing restrictions at the junction with Windermere Road Turnpike Way – Existing restrictions at the junction with Upper Northam Road and south west of Coltsfoot Close

Lower Northam Road and Wadhurst Road – Existing Disabled Parking Places
