

PROPOSED PARKING RESTRICTIONS NOTICE



THE BOROUGH OF EASTLEIGH (ARNOLD ROAD AREA) (RESIDENTS PARKING PLACES AND PROHIBITION AND RESTRICTION OF WAITING) (DISABLED PERSONS PARKING PLACES) (FOURTH ZONE) (CONTROLLED ZONE) (AMENDMENT NO. XX) ORDER XXXX

NOTICE IS HEREBY GIVEN that the Eastleigh Borough Council pursuant to arrangements under Section 19 of the Local Government Act 2000 with Hampshire County Council proposes to make the above mentioned Traffic Regulation Order in exercise of the powers of the said County Council under Sections 1, 2, 4, 32 and 35 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act.

The general effect of this Order will be to insert into The Borough of Eastleigh (Arnold Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Fourth Zone) (Controlled Zone) Order 2004 new and amended waiting restrictions, as detailed below:

Beauworth Close

- Insert Beauworth Close into the First Schedule of the Principle Order so as to entitle residents to apply for a permit to park within zone 4.
- Designate areas as parking places for permit holders zone 4 (Monday-Saturday 8am-8pm).
- Designate an area as waiting limited to two hours maximum stay (no return within 2 hours) Monday-Saturday 8am-8pm (exclusion for permit holders).
- Introduce no waiting at any time in order to prevent obstruction.

Mansbridge Road

- To revoke waiting restrictions along the section of Mansbridge Road which has been stopped up and no longer exists
- To revoke the permit parking bay and disabled persons parking bay which was present to the rear of no. 37 Chestnut Avenue and replace it with no waiting at any time in order to prevent obstruction.

Ovington Road

- Revoke all items within the Principle Order that relate to Ovington Road as it has been stopped up and no longer exists.

Ovington Gardens (East) (Numbers 10-31)

- Insert Ovington Gardens into the First Schedule of the Principle Order so as to entitle residents to apply for a permit to park within zone 4.
- Designate areas as parking places for permit holders Zone 4 (Monday-Saturday 8am-8pm).
- Designate an area as waiting limited to two hours maximum stay (no return within 2 hours) Monday-Saturday 8am-8pm (exclusion for permit holders).
- Introduce no waiting at any time in order to prevent obstruction.
