

**THE BOROUGH OF EASTLEIGH (CHANDLER'S FORD AND HILTINGBURY)**  
**(AMENDMENT NO 4) ORDER 2019 PART 2**

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 24 June 2019 and may be cited as "The Borough of Eastleigh (Chandler's Ford and Hiltingbury) (Amendment No 4) Order 2019 Part 2".
2. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
3. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
4. In this Order
  - a) Principal Order No 1 means The Borough of Eastleigh (Chandler's Ford and Hiltingbury) Consolidation Order 2016 as amended
  - b) Principal Order No 2 means The Borough of Eastleigh (Eastleigh Town Centre) Consolidation Order 2013 as amended
5. The contents of Schedule 1 shall be added to Schedule 1 to Principal Order No 1
6. The contents of Schedule 2 shall be deleted from Schedule 1 to Principal Order No 1
7. The contents of Schedule 3 shall be deleted from Schedule 1 to Principal Order No 2

72a	Ford Avenue	West	From its junction with Leigh Road northwards for 35.5 metres
72b	Ford Avenue	West	From a point 22 metres south of the southern kerbline of Tangmere Rise northwards to a point 25 metres north of the northern kerbline of Tangmere Rise
