The Electoral Register is a public document which can be viewed by appointment only under strict control. It is important that your records are accurate and up-to-date as they will ensure that our staff are able to provide you with the help, advice or support you need. We will, based on your nationality, include your name on the Electoral Register so that you are able to vote by your chosen method. If you do not provide us with this information, then eligible citizens will not be able to vote and you may be breaking the law.

Using information received from the public, registration officers keep two registers. – electoral register and the open register (also known as the edited register). The open register is an extract of the electoral register but is not used for elections. It can be bought by any person, company or organisation. Your name and address will be included in the open register unless you ask for them to be removed. Removing

your details from the open register does not affect your right to vote. You can find out more information about both registers and how they may be used at <a href="mailto:gov.uk/register-to-vote">gov.uk/register-to-vote</a>

## Who we might share your information with

Your personal information will be treated as confidential, but it may be shared with other Council services in order to provide services, meet our legal obligations as a Local Authority, ensure our records are accurate and up-to-date and improve the standard of the services we deliver. It may also be shared with external organisations involved in delivering services on our behalf where the Council has a lawful basis to do so. We will only use your information in ways which are permitted by the General Data Protection Regulation and the UK Data Protection law.

- The Council has a duty to protect the public funds it administers and may use
  the information you have provided or share it with other bodies for the
  purpose of preventing and detecting fraud. This includes participation in the
  Cabinet Office National Fraud Initiative.
- We will NOT use your personal data for marketing products or services.

Anyone who receives information from us has a legal duty to keep it confidential. We are required by law to report certain information to appropriate authorities – for example:

- Where a formal court order has been issued
- To law enforcement agencies for the prevention or detection of a crime
- To the Jury Central Summoning Bureau indicating those persons who are aged 76 or over and are no longer eligible for jury service

After you send your application, it goes through several checks to make sure you're entitled to register.

To verify your identity, the data you proved will be processed by the Individual Electoral Registration Digital Service managed by the Cabinet Office. As part of this process your data will be shared with the Department of Work and Pensions and the Cabinet Office suppliers that are data processors for the Individual Electoral Registration Digital Service. If we wish to use your personal data for a new purpose, not covered by this Data Protection Notice, then we will provide you with a new notice explaining this prior to commencing the processing and setting out the relevant purposes and processing conditions. Where and whenever necessary, we will seek your prior consent to the new processing.

#### How long we keep your data

We retain your personal information for as long as necessary to fulfil the purposes we collected it for, including for the purpose of satisfying any legal, accounting or reporting requirements, or to fulfil statutory obligations.
